0900-0915 Introduction and enrolment

0915-0930 Ship Security Terminology

Lecturer will go through the powerpoint on ship security terminology.

After the session, the candidate will be able to understand the importance of Working knowledge of maritime security terms and definitions, including elements that may relate to piracy and armed robbery

0930-0945 Maritime Security Policy & Responsibility

Lecturer will go through the powerpoint on maritime security policy and responsibility.

After the session, the candidate will have the knowledge of international maritime security policy and responsibilities of Governments, companies and persons, including working knowledge of elements that may relate to piracy and armed robbery.

0945-1000 Security Levels

Lecturer will go through the powerpoint on Security Levels & reporting procedures.

After the session, the candidate will have the knowledge of maritime security levels and their impact on security measures and procedures aboard ship and in the port facilities.

1000-1015 Security reporting procedures

Lecturer will go through the powerpoint on Security reporting procedures. Lecturer to show candidates DOS.

After the session, the candidate will have the knowledge of security reporting procedures. Knowledge of security documentation, including the Declaration of Security Knowledge in handling security-related information and security-related communications

1015-1030 Security related contingency plans

Lecturer will go through powerpoint on SSP and Ship Security Equipment After the session, the candidate will have the Knowledge of the procedures for conducting inspections and surveys and for the control and monitoring of security activities specified in a SSP. Knowledge of security-related contingency plans and the procedures for responding to security threats or breaches of security, including provisions for maintaining critical operations of

the ship/port interface, and including also working knowledge of those that may relate to piracy and armed robbery

1030-1045 <u>Techniques used to circumvent security measures</u>

Lecturer will display video on piracy.

After the session, the candidate will have the Knowledge of techniques used to circumvent security measures, including those used by pirates and armed robbers.
